- 9. Treasurer's summary report:
 - a. Budget for the New Build item to be increased to £6000.00 from the current £1000.00. Agreed by Trustees as we need to ring fence funds for these works. In future reports the item heading should be changed from New Building to Hall Extension.

Business Plan

- 10. There is no major change to the Business Plan. There has been zero cost for the work carried out by our new accountant so this should enhance the 2025/26 projections.
- 11. Carparking policy EVH have had requests to use the carpark for overnight stays by campers and motorhomes. It was agreed by the Trustees that this would not be permitted because of concerns about noise and disturbance to the community. There are also issues related to the lease of the land and general insurance. We will procure a sign which states 'No overnight camping'.
- 12. Mobile phone AH has found a potential SIM only contract for £7/month which is cheaper than our current phone but the contract requires the name of an individual. We would use

this SIM in an early model iPhone. It was decided that a final decision would be made at the next EVH meeting when GM has returned.

Events
